We are aware that you place your trust in us. We see it as our responsibility to protect your privacy. PURPOSES OF DATA PROCESSING

COOKIES

We collect data from visitors to optimise our website and tailor it to your needs. In addition, visitor data is used for statistical research into their surfing behaviour and to offer other products and/or services provided by Venduehuis. The data collected is as anonymous as far as is possible. It is mandatory that our employees guarantee the confidentiality of your data.

Our website uses "cookies" to retrieve the aforementioned data. Cookies are small text files that are placed on your computer. Of course, you are not obliged to accept the use of these "cookies". However, this may limit your ability to use our website. You can also delete the stored "cookies" via your Internet browser.

GOOGLE ANALYTICS

We use Google Analytics to analyse and track how users use our website. When visiting the website, you will be asked for permission to place/use Google Analytics' cookies. The information obtained in this way (e.g., your IP address) is stored on Google servers. Google uses this information to track how our website is used, to provide us with reports on the website and to inform its advertisers about the effectiveness of this marketing technique.

Your personal data, irrespective of the manner in which they have been obtained, shall not be disclosed by Venduehuis to third parties unless, i) this transfer takes place with a processor engaged by Venduehuis for the purpose as listed in this privacy statement, and with which Venduehuis has entered into an agreement to ensure that the processor will provide sufficient guarantees for the safeguarding of this personal data, ii) this disclosure is necessary to execute an agreement entered into by Venduehuis with you, iii) Venduehuis is required by law to transmit personal data to a competent authority, iv) Venduehuis is required by a court ruling to provide this data to a third party, v) it concerns a transfer in the case of your approved use of the Google Analytics "cookie" and/or vi) you have given your consent otherwise.
