

PRIVACY POLICY B.V. Venduehuis der Notarissen te 's-Gravenhage

We are aware that you place your trust in us. We therefore see it as our responsibility to protect your privacy. The Venduehuis respects the privacy of the visitors to its website www.venduehuis.com and ensures that the information you supply is treated confidentially. The processing of personal data by the Venduehuis is done in accordance with the requirements of the Dutch Personal Data Protection Law (WBP).

On this page we inform you about the type of data we collect when you use our website, and why we collect this data.

PURPOSES OF DATA PROCESSING

Your personal data is processed by us within the framework of entering into agreements and execution of these agreements, concerning the Auction services we provide, other information about our Auction services, making a Bid during (Online) Auctions, invoicing, making payments, delivery of Goods to be auctioned and the collection of Goods purchased. Apart from that your personal data is used for our relationship management process.

If you contact us through this Website, or if you send us an email, this data is stored. This data is not however stored for longer than the time necessary for sending a full answer or for processing requests.

COOKIES

We collect data from visitors in order to optimise our Website and to make it more responsive to your needs. Apart from that visitors' data is used for statistical research into the surfing behaviour of the visitors to our Website and to offer other products and/or services.

The data collected is made anonymous as far as is possible, and it is never supplied to third parties without your explicit consent. Our employees have an obligation to guarantee the confidentiality of your data.

This Website uses 'cookies' to gather the data mentioned above. 'Cookies' are small text files which are placed on your computer. You are of course not obliged to accept the use of these 'cookies'. However, not accepting them may result in our Website being less accessible or less easy to use. You can also delete the stored 'cookies' with the use of your Internet browser.

GOOGLE ANALYTICS

In order to analyse and record how visitors use our Website, we use Google Analytics. The data which Google Analytics aggregates (for instance your IP address) is stored on the Google servers. Google uses this data to record information about the use of our website, to report to us about the Website, and to inform our advertisers about the effectiveness of this marketing technique.

YOUR PERSONAL DATA & THIRD PARTIES

The Venduehuis will never supply your personal data to third parties unless, i) it is supplied to a processor for the purposes listed in this privacy statement with which the Venduehuis has an agreement, which ensures that the processor has sufficient guarantees for the safeguarding of this personal data, ii) the Venduehuis is held to supply this personal data to a competent authority on the basis of statutory provisions, iii) the Venduehuis is obliged to provide this data to a third party by a Court judgement.
